**Claims.** Following review, Foster moved, Yordi seconded to approve service claims paid for March 1, 2016 (\$274,220.88) and March 15, 2016 (\$239,090.86). On a roll call vote all voted aye.

#### **Operations**

**FY 17 Annual Service and Budget Plan (ASBP).** The Plan that must be submitted to DHS annually by April 1. Jody Eaton reviewed each section of the ASBP, including Access Points, Targeted Case Management, Crisis Services, Scope of Services and Projection of Need, Financial Information, and Provider Network. Following discussion Clinton moved, Brock seconded to approve the ASBP. On a roll call vote all voted aye.

# **County Updates**

**Story**. Clinton reported of negotiations with Optimae for them to purchase county owned buildings and discussions with Mary Greeley Medical Center to expand crisis services.

**Warren**. Yordi reported on providers' inability to recruit and retain qualified staff as they compete with MCOs.

**Hamilton.** Bailey reported that legislators helped prompt IME to get past due payments to Central Iowa Recovery. Treibel reported on the transition of Case Management to the MCOs.

DHS Case Management Supervisor Terri Kuntz reminded the Board that DHS TCM is a designated provider in CICS and would like to be offered to Amerihealth clients as a choice as they are transitioned from our county case management programs.
